**Instructions to Completing the Power of Attorney (POA) for  
Electronic Export Information (EEI) - Foreign Principal Party in  
Interest (FPPI)**

The purpose of this Power of Attorney to Transmit Electronic Export Information is to provide **Southwest International Customs Services LLC** with the authority to transmit EEI (formally referred to as SED) data on behalf of the Foreign Principal Party in Interest (FPPI) to the Automated Export System (AES).

The Foreign Principal Party in Interest (FPPI) is the party abroad who purchases the goods for export or to whom final delivery or end-use of the goods will be made. This party may be the Ultimate Consignee. In a routed export transaction, the FPPI is responsible for facilitating the movement of the cargo and authorizing a U.S. Agent or the U.S. Principal Party in Interest to file the Electronic Export Information in the Automated Export System (§30.3(e)).

1. Name of The Foreign Principal Party in Interest (FPPI)
2. FPPI organized and doing business under the laws of the State or Country of

5. Only an officer of the corporation may sign the POA for EEI filing
6. Must sign; secretary, treasurer, controller, owner, partner, vice president or higher.

act as authorized agent for export control, U.S. Census Bureau (Census Bureau) reporting, and U.S. Customs  
and Border Protection (CBP) purposes. Also, to prepare and transmit any Electronic Export Information  
(EEI) or other documents or records required to be filed by the Census Bureau, CBP, the Bureau of Industry  
and Security, or any other U.S. Government agency, and perform any other act that may be required by law  
or regulation in connection with the exportation or transportation of any goods shipped or consigned by or to  
the Foreign Principal Party in Interest, and to receive or ship any goods on behalf of the FPPI.

The Foreign Principal Party in Interest hereby certifies that all statements and information contained in the  
documentation provided to the authorized agent and relating to the exportation will be true and correct.  
Furthermore, the Foreign Principal Party in Interest understands that civil and criminal penalties may be  
imposed for making false or fraudulent statements, or for the violation of any United States laws or  
regulations on exportation.

This power of attorney is to remain in full force and effect until revocation in writing is duly given by the  
Foreign Principal Party in Interest and received by the Authorized Agent.
